NOTIFICATION OF ESSENTIAL MAINTENANCE WORKS M1 Junction 19 – 21 Northbound and Southbound

I'm writing to let you know that we'll be carrying out essential maintenance work to the M1 northbound and southbound carriageway between Junction 19 and Junction 21, including the exit and entry slip roads at Junction 20.

During our comprehensive scheme of work, we'll:

- repair and replace damaged drains
- resurface both northbound and southbound carriageways
- refresh road markings and road studs
- repair any necessary bridge joints

Once completed, all road users will benefit from improved road safety and a smoother driving experience.

When will the work take place?

Work is due to start on **30th May 2022** and is scheduled for completion by **Mid September 2022**.

Please note that all our planned works are subject to change due to weather conditions, significant events or unforeseen circumstances.

How will the work affect traffic?

To keep our workforce safe and the duration on the works as short as possible, minimising disruption to the local community, residents, businesses and road users, we'll work under full carriageway closures, in phases, as follows:

Northbound carriageway

- Full carriageway closure from **30th May – Mid July**

- **Monday to Thursday, 9pm to 6am and Friday to Saturday, 9pm to 7am**

Southbound

- **Monday to Thursday, 9pm to 5am and Friday to Saturday, 9pm to 7am**
- Full carriageway closure from **Mid July – Mid September**

Some elements of the work to the exit and entry slips at junction 20 will require full weekend closures from **9pm Friday to 6am Monday**.

During these full road closures, we will put in place fully signed diversion routes which have been agreed with the local authority.

If you'd like more information about the different phases of our work or a copy of the diversion route drawings, please feel free to get in touch with us.

How will the work affect businesses and residents?

We will make sure that access to businesses and residences is maintained wherever possible. We will also have a dedicated Public Liaison Officer on hand to answer any questions.

We apologise for any inconvenience caused and will do our very best to complete the work as quickly as possible, keeping disturbances and noise to a minimum.
